Protection of confidential management documents using Safeguard PDF Security

Summary

The Austin Diagnostic Clinic need to make available management documents containing proprietary and/or confidential information to their physicians – who are the owners and managers of the Clinic. Physicians are not always able to attend management meetings – they have patients as their top priority, so there is a need to be able to share confidential information with physicians who are unable to attend meetings.

The Austin Diagnostic Clinic purchased Safeguard PDF Security to provide their document security solution, allowing them to achieve their management requirement without compromise to security or healthcare regulations.

The Problem

Physicians, who face tremendous demands on their time, are obviously not always available to attend meetings. Patients must come first. Yet when the physicians are also the owners and managers, it is essential that they have access to key management documents giving them up to date management information about the overall practice, as well as their own area. Obviously such documents need to be delivered securely, because they may contain confidential and medically sensitive patient information, company information, and clinical data.

The Austin Diagnostic Clinic's documents are created in different ways and are in different formats, including some from proprietary applications. This presented a major problem in identifying a generic document security solution.

The most effective security approach they used for controlling access to and use of documents, prior to implementing Safeguard PDF Security, was to restrict access to them using network access controls. However, a number of potential weaknesses were identified in this approach, and it was concluded that a more rigorous security solution had to be identified.

The Austin Diagnostic Clinic also wanted to ensure that confidential and sensitive documents were only made accessible for a limited amount of time. This is a critical requirement when physicians are accessing clinical data, because of the need to be

The Approach

A strategic decision was taken to convert all management documents to use the PDF format. This was decided in order to create a single document architecture for document security and management. This decision proved to be significant because it simplified the subsequent choice of infrastructure and approach, since they had only to apply one common architecture for format, delivery and security.

The Austin Diagnostic Clinic then evaluated in detail several potential PDF security solutions providers that appeared to allow them to protect and distribute their confidential documents securely, before selecting Safeguard PDF Security as their preferred solution.
